ALLIED HEALTH RESEARCH FUNDING

WHAT IS THE GOAL OF ALLIED HEALTH RESEARCH?

Research performed by allied health professionals crosses the lifespan; from developmental disorders in infants to health outcomes and quality of life related to aging. Research undertaken by allied health professional is science-driven and evidence-based where the objective is to apply research findings to grow capacity and advance best practices in allied health professions.

FUNDING HAS DECREASED FOR MEDICAL AND ALLIED HEALTH RELATED RESEARCH

- 5% across the board budget cuts to NIH (\$1.55B), NSF (\$288M), and CDC (\$285M) for FY2013. Consequences of decrease funding include:
 - o Approximately 700 fewer competitive research project grants will be issued by NIH and a 1,000 fewer will be funded by NSF in 2013.
 - o No increase in stipends for graduate and post-doctoral award recipients in FY2013
- o Cuts to research may delay progress in medial breakthroughs
- o Reduce ability to prevent leading causes of illness and death: cancer, heart attack, stroke, diabetes.
- o Decreased research funding present a risk to the allied health workforce and future job creation.



WHICH FEDERAL AGENCIES CURRENTLY PROVIDE SUPPORT FOR ALLIED HEALTH RESEARCH?

- National Institutes of Health (NIH). It comprises 27 separate institutes, centers, and offices. As of 2003, the NIH was responsible for 28%, about US\$30.7 billion of the total biomedical research funding spent annually in the U.S www.nih.gov
- National Science Foundation (NSF). It supports fundamental research and education in all the nonmedical fields of science and engineering. With an annual budget of about US\$7.0 billion (FY2012), the NSF funds approximately 20% of all federally supported basic research. www.nsf.gov
- Centers for Disease Control and Prevention (CDC) is the national public health institute of the United States.
 CDC's FY2008 budget was \$9.2 billion. www.cdc.gov
- Health Resources and Services Administration (HRSA) is the agency for improving access to health care services for people who are uninsured, isolated or medically vulnerable. The agency's \$7 billion budget (FY2008) provides direct health care to 23 million people. www.hrsa.gov
- Agency for Healthcare Research and Quality (AHRQ) mission is to improve the quality, safety, efficiency and effectiveness of healthcare for Americans.
